



# Prices for private dog training and behaviour therapy

## SERVICES

We distinguish between obedience and behaviour services:



Obedience = You just want to perfect specific training exercises (e.g. sit, stay, leave it, polite greeting, etc.) and there is no abnormal behaviour → We start with *Practical training sessions*.



Behaviour = The dog is too overwhelmed to listen or function in certain situations (severely over-stimulated, scared, angry, stressed, etc.) → We start with *Behaviour evaluation and advice* and only then plan *Practical training sessions*.



### Behaviour evaluation and advice

The *Behaviour evaluation and advice* appointment is only required for Behaviour cases.

1. Written evaluation (with report): 2-hour in-home evaluation and advice session, followed by a report showing:
  - o Written summary of the findings and advice
  - o Diagnosis and underlying causes
  - o Fitting exercises are explained, and detailed handouts are given
  - o A training plan and strategy is developed in accordance to your priorities and preferences
  - o Management steps are given for the short-term

**During this consultation, hardly any practical training will take place. This appointment focuses on diagnosis and planning. It is not a training session.**

Often, follow-up practical training sessions form part of the recommendations.



### Practical training sessions (after Behaviour evaluation consultation)

2. Training sessions package: 4x 45-minute practical training sessions.



### Practical training sessions (without Behaviour evaluation consultation)

3. Training sessions package: 1x session of 1.5-hour long, and 3x 45-minute practical training sessions. The intake will take place during the first, longer session.




Option 3 is only available to dogs who do not suffer from behaviour problems. It focuses on pre-defined obedience exercises. Underlying behaviour issues are not treated (e.g. aggression, excitement, fear, separation problems, etc.).

### Additional services (on request)

4. Evaluation extension: Sometimes the planned time is not enough and it is possible to extend the session. In these cases, every additional 30 mins is charged (rounding up from 20 mins.). This is only done with your explicit permission.
5. Remote consults: Training and advice sessions by Skype, telephone or e-mail, for remote clients. Should extensive communications be my own initiative, I either ask for permission or do not charge.
6. Stimulus planning: If you cannot find any, you can request for us to arrange for a volunteer dog or person during some of our sessions (e.g. a volunteer 'target' dog or person if your dog barks at other dogs or visitors).
